## 2010 Triple Threat Camp Enrollment Agreement

Parents and Students are required to sign this agreement and return it along with your other registration information. The undersigned (“Parent”) submits this enrollment request for his/her child in The School of

Performing Art’s Triple Threat Camp and agrees to the following terms.

1. **Payment:** The Parent signing this agreement agrees to pay the required tuition stated. The camp deposit is not refundable.
2. **Withdrawal:** (Non-refundability of Tuition and Fees): The withdrawal, suspension or expulsion of the student from the camp, shall not relieve the Parent of any obligations under this agreement, including the obligation to pay tuition charges.
3. **Enrollment/Indemnity:** While every consideration will be made to accommodate the needs of each student, The School of Performing Arts reserves the right to withhold or reconsider enrollment or send a student home should issues require support beyond the capabilities of our staff or should a student/parent refuse medical/counseling services deemed necessary by The School of Performing Arts.
4. **Release/Waiver:** The Parent agrees to and does hereby release The School of Performing Arts from any and all liability for any injury or damages suffered to the student during his/her camp experience, including participation in any dance or recreational activity, in the absence of any negligence by The School of Performing Arts or its staff.
5. **Damages:** The Parent assumes responsibility for any damage to The School of Performing Arts and/or NCC’s property caused by the student or chargeable to him/her under the rules and regulations of the camp. The Parent acknowledges and agrees that The School of Performing Arts shall have no responsibility whatsoever for any damage or loss sustained by the Student to his/her personal property while it is located on The School of Performing Arts or NCC’s premises.
6. This Agreement may not be modified orally. It may only be modified in writing signed by both parties.
7. In the event it shall become necessary for The School of Performing Arts to maintain legal action under this contract, it is agreed that The School of Performing Arts, in addition to any damages or other costs to which it may be entitled, shall also recover its reasonable attorney’s fees expended in the prosecution of said action.
8. I understand that I am financially responsible for the camp for which I am registering. I have also read and understand the registration and refund policies of The School of Performing Arts. I give SPA permission to provide emergency medical care, hospital or clinic treatment or to administer minor medicine provided through the head counselor. I hereby waive liability against The School of Performing Arts for such care or provided transportation to such locations as deemed necessary by The School of Performing Arts. I give The School of Performing Arts permission to photograph and publish photographs and video of my child participating in instructional and/or social activities at the camp, or photos and video of any performance made while enrolled in the course at The School of Performing Arts, which permission shall remain in effect until revoked, in writing by myself to The School of Performing Art’s staff.
